# Tehama County Grand Jury Citizen Complaint Form Instructions for Preparing the Tehama County Citizen Complaint Form

- 1. **Complainant** All communications with the Grand Jury are confidential. Your confidentiality will be protected. You may submit an anonymous complaint; however, this could make it more difficult for the Grand Jury to investigate and respond to the allegations.
  - a. Include your name, complete mailing address, phone number and email address.
  - b. The grand jury may or may not contact you for further information.

### 2. Subject of Complaint

- a. Include name, address and telephone number of the person, official, department, agency or entity the complaint is regarding.
- b. If the complaint is regarding an individual in an organization, include the individual's title and position in the organization.

### 3. Attempted resolution

- a. Include name, phone number and address of each individual, department or agency or media entity you have contacted prior to filing out this complaint.
- b. Briefly describe the results of each of the contacts you made while trying to resolve your complaint.

#### 4. Brief Summary of Complaint

- a. Be as concise as possible, providing dates, times, and names of individuals involved. Submit one Complaint Form for each complaint.
- b. Cite specific instances as opposed to broad statements.
- c. You may include copies of documents, pictures and correspondence to support your complaint they will not be returned to you.
- d. If more room is required, attach additional sheets include how many sheets are attached on the last line of the first sheet (i.e. 3 additional sheets attached). Number the sheets.

#### 5. Possible Complaint Resolution

a. Briefly describe the results you would to like to see from a Grand Jury investigation.

#### 6. **Disposition of Complaints**

- a. Please be advised that each complaint is considered on a case-by-case basis. Not all complaints can or will be investigated and/or acted upon due to the nature of the complaint, available resources and other considerations.
